Terms of Service

1. About Us

2. Eligibility

3. Your Account

You are responsible for:

- keeping your login credentials secure,

We may suspend or terminate accounts that breach these Terms or that present security, legal, or operational risks.

4. Use of the Services

 - misuse influencer data or use it for purposes outside campaign management;

 - interfere with the functioning, security, or integrity of the Services;
 - create accounts using false identities or attempt to access accounts belonging to others.

We reserve the right to remove content or restrict access for any breach of these Terms.

5. Influencer Data and Third-Party Integrations

The Services integrate with third-party platforms such as Meta (e.g., Instagram) for the purpose of retrieving public-facing analytics and metrics authorized by you.

You acknowledge that:

- Data retrieved through Meta or other integrations is subject to those platforms' own terms and APIs.
 - You must comply with all applicable social platform rules when connecting accounts.
 - We do not guarantee the accuracy or availability of third-party data.

You must not use data obtained from Club Sauce to harass, misuse, or unlawfully profile influencers or any third party.

6. Payments and Billing

Payments for paid features or subscription plans are handled securely through Stripe.

By subscribing or purchasing services:

- You authorize Stripe to process payments on your behalf.
- You agree to provide accurate billing information.
- You acknowledge that Club Sauce Ltd does not store full payment card details.

All fees are listed exclusive of VAT unless stated otherwise.

We may change pricing with reasonable notice.

7. Intellectual Property

All intellectual property in the Services — including software, branding, design, text, graphics, databases, and underlying technology — belongs to Club Sauce Ltd or our licensors.

You are granted a non-exclusive, revocable, limited license to use the Services for your internal business purposes.

You must not:

- Our total liability arising out of or in connection with these Terms will not exceed the total amount you have paid to us in the 12 months preceding the claim.

11. Termination

We may suspend or terminate your account if you:

- breach these Terms,

- pose security, operational, or legal risks.

You may stop using the Services at any time.

Termination does not affect rights or obligations already accrued.
